Selected bids are hereby invited by the **Superintendent, Sambhunath Pandit Hospital, Kolkata** from bona fide and reputed individual/firm possessing for sale of some non-serviceable items **(SNPH, Electrical Section, PWD)** through public auction on "as in where is" basis as per the attached list **(Annexure I)** with the following terms & conditions during the Financial Year 2025-2026

a) The intending bidder may inspect the materials at site between 11:30 AM to 12:30 PM in presence of concerned authority on 26/6/25. Any dispute made afterward regarding quality of materials will not be entertained.

b) The intending agencies/individuals must have to produce up to date valid specific Trade License, Professional Tax Registration, PAN Card and E-waste Registration Certificate at the time of application.

c) Valid & up to GST & ITR may be applicable in case of financial evaluation to determine the highest one among bidders with same rate.

d) Bidder have to submit all the above mentioned document as Para no (b) & (c) with offered rate chart after completion of inspection in between 12:30 Pm to 03:00 pm on the same days (26/6/25) in sealed envelopes to the concerned authority.

f) The successful bidders on receipt of the necessary lifting order shall remove the auctioned materials from the site in consultation with the concerned authority as per Govt. norms.

g) If any damage or losses occur in Govt. properties during lifting, loading & carrying of auctioned materials inside hospital campus the bidder will be responsible to compensate at his own cost.

h) The undersigned reserve the right of cancellation of any or all the offer with whole auction procedure at any time with or without direction of the higher authority.

i) In case of any dispute, the decision of the Superintendent, Sambhunath Pandit Hospital will be final.

j) Floor price of materials are protected and proposed by the Executive Engineer, PWD (Electrical), and accepted by the Condemn & Disposal Committee, SSKM Hospital and thereafter by the Hospital Authority, Sambhunath Pandit Hospital and not changeable. Offer rate from the bidder regarding any item as mention in Annexure- I, lower than the proposed floor price, will not be entertained and will be declared as disqualified. Total floor price (Rs) value will be considered first and he who will tender the best total price value will be "selected".


k) Cost of lifting, loading & carrying will be borne by the bidder/bidders.


