The decision of the Tender Selection Committee will be the final and absolute in this respect.







Introduction

Before formulating the bid and submitting the same to the purchaser, the bidder should read and examine all the terms, conditions, instructions, checklist etc. contained in the TE documents. Failure to provide and/or comply with the required information, instructions etc. incorporated in these TE documents may result in rejection of its bid.

General Guidance for e-Tendering:-

Instruction /Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tender.

1. Registration of Bidder:-

Any Bidder willing to take part in the process of e-Tendering will have to be enrolled and registered with the Government e-procurement system and they can do so by visiting <https://wbtenders.gov.in> (herein after mentioned as the “prescribed website” or “**website**” or “**e-tender website**”) and following link on e-tendering site (herein mentioned as “the Prescribed web portal” or “web portal” or “e-tender web portal”).

2. Digital Signature Certificate (DSC):-

Each bidder is required to obtain Class —II or Class — III Digital Signature Certificate (DSC) for submission of tenders from the approved service providers of the National

Informatics Centre (NIC) on payment of requisite amount; the details of which are available at the web site as stated above. The DSC is given as a USB e-Token.

3. The bidder can search and download NIT & Bid Document electronically from the above website once he/she/they log(s) on to the website mentioned in clause using the Digital signature Certificate. This is the only mode of collection of Tender/Bid Document.

4. Submission of bids.

Both Technical bid and Financial Bid, duly signed digitally signed, are to be submitted

Concurrently in the “prescribed website”. All the documents, to be scanned and uploaded in the web portal must be in English language.

The Bids are to be submitted online in the website/web portal in two folders at a time, one each for Technical Bid and for Financial Bid, before the prescribed date & time using the Digital Signature Certificate (DSC) .The documents to be uploaded are to be scanned for viruses and are to be duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

SUBMISSION OF THE TENDERS: The tender is to be submitted in a two Bid System.

An attested copy of the valid license has to be submitted.

Copies of documentary evidence of experience having successfully completed similar works during the last Three years should be submitted.(Form —A)
G	The Tenderer must submit last years audited balance sheet reflecting the annual turnover which should be not less than or equal to Rs.2.00 Cr. (Two Crore) or more per year

(B) Non-Statutory Cover:

1. Click the check boxes beside the necessary documents in the My Document list and then click the tab “Submit Non Statutory Documents” to send the selected documents to Non-Statutory folder.

2.Next Click the tab “Click to Encrypt and upload” and then click the “Technical” Folder to upload the Technical Documents using: (a) multiple scan (b) black and white scan (c) scan resolution should be within 250.

7. FINANCIAL COVER :

The folder as “Financial Bid” shall contain:

Base Rate per accounting unit inclusive of cost of pesticides and related labour, Entry Tax, Customs Duty (if applicable), Transportation Charges, Insurance, Delivery Charges, Freight Charges, etc. and exclusive of VAT / GST & Service Tax (wherever applicable), etc. To be quoted.

8. The tenderer are required to submit the hard copies of Technical bid in the receiving section of SUPERINTENDENT office, SAMBHUNATH PANDIT, HOSPITAL, Kolkata Submission of

hard copy of Financial Bid is totally prohibited and only be submitted through on line through NIC portal.

9. PROCEDURE FOR DEPOSIT OF EMD/BID SECURITY RELATED TO e-PROCUREMENT OF THE STATE GOVERNMENT DEPARTMENTS: - Earnest money Rs. 20, 000.00 (Rupees twenty thousand) only.

The earnest money of the tenderer is liable to be forfeited if the tenderer withdraws his tender as a whole or for any particular item or items at any stage after opening of the tender or fails/refuses to enter into written agreement for any or all of the items of his accepted bid within the time specified when requested to do so or fails to furnish Performance Bank Guarantee within the stipulated time. EMD should be deposited online in the Pooling Account of Government of West Bengal maintained at ICICI Bank, RN Mukherjee Road Branch in the manner as prescribed in Government Order no. 3975-F(Y) dated 28/07/2016. (Order copy is available at the site-www.wbfin.nic.in) Hard copy of Bid A should reach the office on or before the stipulated date as mentioned in clause 1.

10. Forfeiture of EMD (Penalty):

- i) If the contractor fails or neglects any of his obligations under the contract, Tender selection committee reserve the right to forfeit either whole or any part of EMD furnished by the bidder as penalty for such failure.

ii) **Refund of EMD :**

The EMD will be returned after expiry of contract period on satisfactory completion of the job/contract. No interest is payable on EMD.

11. RATE:

The rate should be quoted in Indian Rupees only as mentioned in the appropriate column of the “BOQ”.

- a. The rate should be quoted on monthly Basis in the appropriate column of the “BOQ”
For General Pest Control:
- b. The rate should be quoted per bed basis for Bedbugs Control (**As and when required basis**)
- c. The rate should be quoted per Sq Ft basis for Termite Control (**As and when required basis**)
- d. The rate should be quoted per Glue Board wise for Rodent Control (**As and when required basis**)

The vendor, who will be selected as L1 bidder for General Pest Control, will also be awarded for Bedbugs Control, Termite Control and Rodent Control services (**As and when required basis**).

Successful bidder will be needed to provide details rate of particular items prescribed in catalogue before signing of contract.

12. OPENING OF TENDER

- a) The Tender selection committee will open the bids after the specified date and time as indicated in the NIT.
- b) **Opening of Technical Proposals:** Technical proposals will be opened by members of the Tender Selection Committee electronically from the website using their Digital Signature Certificate (DSC).
- c) In the Technical Proposal, the Cover (folder) for Statutory Documents will be opened first and if found in order, the cover (folder) for Non-Statutory Documents will be opened.
- d) **IF ANY DOCUMENT REQUIRED TO BE SUBMITTED FOR TENDER BY THE BIDDER IN HIS TECHNICAL PROPOSAL IS NOT SUBMITTED OR IS FOUND TO BE DEFICIENT IN ANY MANNER AT ANY STAGE AFTER OPENING OF BID, THE BID MAY BE SUMMARILY REJECTED.**

13. Evaluation of the tenders:

- (a) During the tender evaluation process, Technical Bid will be opened first and Financial Bid will be opened subsequently. Those Bidders who have qualified in respect of the essential & other requirements in Technical Bid will be identified and their financial bid will be opened. The financial bid of those tenderer failing to meet the technical & other requirements of participating in the tender will not be opened and be rejected. Final selection of the lowest bidder in respect of Financial Bid is subject to further verification.
- b) Acceptance of the lowest tender is not obligatory.

THE DECISION OF TENDER SELECTION COMMITTEE WILL BE FINAL AND BINDING IN THIS MATTER.

14. Before submission of the Tender, tenderer shall sign each page of all of its relevant papers mentioned in check list with date & page number. The additional alternative and or subtractive clause (if any) shall also to be signed by the tenderer.

15. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. Submission of a tender by a tenderer implies that he has read this notice and all other

contract documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors bearing on the execution of the work.

Tenderers are advised to visit the place of work for assuring the nature and volume of work realistically before quoting the rates.

16. AGREEMENT:

The successful tenderer shall sign an agreement within 14 days from date of “ acceptance of the tender” by the Tender Selection Committee of Sambhunath Pandit Hospital, Kol-20.

Non judicial stamp paper. All legal expenses, incidental thereto shall be borne by the contractor. If the tenderer fails to sign the agreement within the stipulated time. Tender selection committee reserves the right to forfeit the Earnest money deposit submitted by the contractor.

17. VALIDITY OF CONTRACT:

The period of contract shall be for a period of 1 (**ONE year**) from the date of start of contract. However, the contract may be extended every **Six months** for a period of maximum **Two years** on mutual consent. Tender selection committee reserves the right to terminate the contract by giving 15 days notice and without assigning any reason thereof.

18. The work should commence within a week from the date of receipt of Work order, or as intimated to tenderer.

19. Tenderer along with his/ her agents, representatives or employees will be allowed to enter into the Building for the purpose of rendering the said services. Tenderer is responsible to make compensation for any loss or damage or theft caused to the premises and property by his/ her agents representatives or employees while rendering the said services, by adjustment from their bills.

20. Tenderers will have to pay the amount equivalent to the loss sustained to the SNPH, If any due to negligence on the part of tenderer or his/ her workers, while executing the contract during the contract period.

21. Tenderers shall have to entirely responsible to maintain separate records, duly signed by the concerned HOD/In-charge on monthly basis, clearly indicating minimum frequency of operation **twice in a month**. In case of unsatisfactory results minimum frequency may increased.

22. Terms and Mode of Payment

The terms of the payment are as follows:-

a) Payment shall be made in Indian Rupees subject to recoveries, if any, by way of liquidated damages or any other charges as per terms and conditions of contract.

b) Payment shall be released on quarterly or monthly basis for actual work done only. Bills in duplicate along with work completion report shall be submitted for verification and acceptance of Medical Superintendent SNPH, KOL.

[<i>*One Glue Board can be used / 20 beds in bedded areas & maximum 3 Glue Board can be used at a time in non bedded areas</i>]

23. Late/delayed tenders due to any reason, whatsoever will not be accepted/ considered, at all, under any circumstances.
24. All the materials, Equipments, Tools including disinfectants etc. Requested for this work shall be arranged by the contractor at his own cost.
25. Contractor shall also take all precautions to ensure that no damage/ staining happen to any furniture fixture surface by way of spray used by them or their staff. In case they said
26. Surfaces are damaged or gets dirty the contractor shall ensure that the persons deployed by him clean the said surfaces immediately.
27. The contractor will furnish & submit the details list of employees who will be deputed to this hospital for this job.

28. WITHDRAWAL /CANCELLATION & PURCHASE POLICY OF TENDERING AUTHORITY:

- i) The tendering authority reserves the right to withdraw any item from the tender at any stage. The selection of such item, if already made in favour of any tenderer, shall be treated as cancelled.
- ii) The tendering authority reserves the right to reject or accept any tender or part thereof at any stage or to split any tender without assigning any reason. Withdrawal of tender or any revision after submission of tender by the tenderer will not be allowed.
- iii) The tendering authority reserves the right to accept or reject any tender, in part or in full, without assigning any reason.
- iv) The tendering authority or the Contracting Officer shall be at liberty to terminate contract issuing 15(fifteen) days notice if the contractor assigns, sublets either in whole or in part of the contract or in the opinion of the tendering authority or the Contracting Officer, any contractor found guilty of misconduct or found any dissatisfactory execution of the contract. The contractor shall not be entitled to claim damage what so ever due to such termination of the contract.

29. NON- CONVICTION CERTIFICATE:

The tenderer will also submit an affidavit (Non Judicial Stamp of Rs.10.00 (Rupees Ten only) in the prescribed Pro-forma attached herewith from Notary/ first class Judicial Magistrate/Executive Magistrate (Annexure II)

30. PENALTY CLAUSES:

The tender selection committee reserves the right to declare a registered companies / reputed organization/firm /experienced agency/ licensed contractors blacklisted for three (03) years due to the following reasons:

- i) If the approved tenderer withdraws from agreement after achieving the “Lowest Quoted Tenderer”
- ii) In consequence of submission of false or fabricated documents by any registered companies / reputed organization/firm /experienced agency/ licensed contractors for participating in the tender, if proved later on.

Financial Penalties for deficiencies in services/supplies during the period of the tender and its subsequent extensions:

In the event of failure to complete the work as per Work Order within stipulated period, the EMD may be forfeited and next lowest Bidder will be invited.

31. The Tender, submitted by the firm who have already been declared as Black Listed or whose contract was terminated for dissatisfactory similar project or who was unable to execute any similar order in this hospital or in any other Hospital run by The Govt. Of West Bengal, will not be considered even his being the lowest rate.

32. Regarding Cost for providing general pest control, eradication of mosquitoes and rodent control services, Abnormal Low Rate or Abnormal High Rate (in comparison to the market Rate) will not be considered.

33. Power of Attorney:

In the event of the tender being submitted by a firm, it must be signed separately by each member thereof, or in the event of absence of any partners, it must be signed on his behalf by a person holding “Power of Attorney” authorizing him to do so. Such “Power of Attorney” is to be produced with the Tender and in the case of the firm, carried on by one member of Joint Family, it must be disclosed that the firm is duly registered under the “Indian Partnership Act”.

34. PENALTY FOR FORMATION OF CARTEL OR FURNISHING OF FRAUDULENT/ MISLEADING DOCUMENTS:

If during the tender process or at any state during the validity of the tender period, it is found that a tenderer(s) has formed a cartel in what so ever form or name to fix up the rates or suppliers to the detriment of the fairness of the tender process, penal measures shall be initiated. Similar penal measures shall also be initiated against those tenderer who have submitted false/ misleading/ fraudulent documents or made incorrect declarations.

The penal measure will be

- i) Forfeiture of Earnest Money.
- iii) Cancellation from the approved list of supplier

35. Notification of Award:

- a) The Tender Selection Committee may be notifying the list of successful bidder(s) online. In addition, each successful bidder shall be notified in writing, by registered/ speed post or by fax/ telex/ cable/ email (to be confirmed by registered / speed post) that its bid have been selected by the Tender Selection Committee.
- b) If required the successful Bidder shall also physically submit original documents (uploaded by him online at the time of bidding) for verification before issue of contract.

36. During the scrutiny, if it comes to the notice to tender inviting authority that the credential or any other paper found incorrect/ fabricated, that bidder would not allowed to participate in the tender and that application will be out rightly rejected without any prejudice.

37. Scope of work :

The work requires to provide necessary treatments to the buildings and open area of the compound / terrace like bedded and non —bedded area including OT, ITU, Cath Lab, Wards, ICCU, Hospital Kitchen , Hostel, Morgue, Offices, all toilets, back areas, passages, basement, garbage area etc,to make it free from Pests & Rodent.

38. Job Description:

- 1) **General Pest Control:** which means three phases complete pest control/Management, Spraying pesticides, insecticides especially mosquito killers, Cockroach killers, Spider killers. Any types of anti Bedbugs treatments, anti termite treatments (**As & When Required Basis**). Killing of rodents (**As & When Required Basis**).

- (i) The Pest control should cover all the places like spray under the tables, chairs, Almirah, on and around the pile of files, on wooden furniture, on false ceiling, on all staircases, on lift lobby, on all toilets drain ducts, on all pantry rooms, in all stores and any hidden space under the furniture, outside the premises, to cupboards, vaults, lockers, bathrooms, gully taps, common passage, food preparation area and cafeteria and should leave no space unattended.
- (ii) Agencies must ensure that the pest control once done shall remain effective up to next pest control failing which it shall have to be done again without any cost.
- (iii) The pesticides, etc. Used for pest/rodent control, should not have adverse impacts on human health. (A list of Approved Pesticides & Insecticides enclosed).

(iv) The chemicals/pesticides used by the agency be purchased from reputed concern and should be ISI Marked and/or WHO approved or approved by the registration committee to control household pests, under the insecticides act, 1968.

(v) The contractor shall submit documentary proof of purchase of Insecticides only from original manufacturer or their authorized dealer at the time of each treatment. Only sealed container of insecticides shall be opened for use in presence of supervisor at the time of each treatment and custody of purchased chemicals should be under the control/custody of the Supervisor.

(vi) No outdated chemicals should be used and all formulation/pesticides to be used for pest control treatment shall be safe for human beings/patients friendly and shall not have any detrimental effect on such materials and that should be none staining

- (vii) **Within the specified guarantee period as per frequency of disinfestations of the premises of SNPH, KOL, if complaints are received by the Hospital Administration. 39. INITIAL BUILDING INSPECTIONS


