- The bidder must enclose a copy of the License to Manufacture for Sale or Distribution of Medical Device/ The Registration
 Certificate to Sale or Distribute or offer for sale or deliver Medical Devices issued by the Competent Authority in accordance with
 the Medical Device Rules, 2017.
- The Purchasing Committee has every right to accept/ reject any quotation without assigning any reason thereof.
- No other charges except the GST will be acceptable.
- Goods must be delivered within 7 (seven) days from the date of supply / work order.
- The quotation should be valid for 365 days from the date of opening of quotation or till the procurement amount when reaches up to the maximum limit (Rs. 1 lac), whichever is earlier.
