The Sealed quotations must be dropped at the Office of the Superintendent, SNPH on and from 20-01-2025 within 27-01-2025 up to 02:00 P.M. Quotation will be opened as on 27-01-2025 at 03:00 P.M. at the office chamber of the Superintendent.

Demonstration is mandatory within next 2 working days of the concerned ward, after opening Bid, failing which the quotation will be treated as cancelled.

- The rate should be quoted as per specification.
- Item name, Unit & Specification should not be changed.
- Rate should be quoted as per mentioned table.
- Rate should not rate notified by the NPPA & MRP.
- The bidder must enclose a copy of the License to Manufacture for Sale or Distribution of Medical Device/ The Registration Certificate to Sale or Distribute or offer for sale or deliver Medical Devices issued by the Competent Authority in accordance with the Medical Device Rules, 2017.
- The Purchasing Committee has every right to accept/ reject any quotation without assigning any reason thereof.
- No other charges except the GST will be acceptable.
- Goods must be delivered within 7 (seven) days from the date of supply / work order.
- The quotation should be valid for 365 days from the date of opening of quotation or till the procurement amount when reaches up to the maximum limit (Rs. 1 lac), whichever is earlier.
- If the L1 bidder found not able to comply the order within the stipulated time mentioned above, then the order will be automatically treated as cancelled. The undersigned will have the right to place the same before the L2 bidder without any communication to the L1 bidder.
- If any dispute OR reaction after using of the item from the vendor, the selected bidder will have to change the same without charging any cost.
- **Lowest bid is not the sole criteria for selection; quality of article and technical conditions mentioned above must be fulfilled.**
- Bill amount will be paid only after availability of allotment of fund in IFMS.
